PROCEDURE

- 1. Premix phase A, mixing until homogenous.
- 2. Grind phase B and add to phase A.
- 3. Add phase C to the batch mixing until homogenous.
- 4. Roll into a sheet and press out tablets.

DIRECTIONS FOR USE

- **Option 1** Put a tablet in the palm of your hand, add a little water, rub and enjoy the rich creamy foam.
- **Option 2** Place the tablet(s) into the spray bottle, add enough water for your cleaning routine and wait for the tablets to dissolve (approximately 5-10 minutes). Put the spray pump on the bottle and spray liberally onto the body, rub gently and then wash off for the quickest clean ever. Empty any excess and re-use the bottle for the next clean.
